#### Greetings all,

I am pleased to announce the appointment of Karyn Tribble, PsyD, LCSW as the new Director of Behavioral Health for Alameda County.

Dr. Tribble has over 20 years of experience in the behavioral health field and is an experienced and dynamic administrator. She currently serves as the Chief Administrative Officer for Behavioral Health Services in the Alameda Health System (AHS), which includes responsibility for overseeing AHS' Behavioral Health Services departments providing Integrated Outpatient Services, system Consultation and coordination, Substance Abuse services, Partial Hospital and Intensive Outpatient Services, and serving as the Administrative and Operational Executive for the John George Psychiatric Hospital Facility. Dr. Tribble began her role at AHS in 2017 after serving as Deputy Director and Interim Director for the Alameda County Behavioral Health Care Services Department (ACBH) from 2015 until her departure in 2017.

Prior to the above positions, Dr. Tribble held a number of other positions in the behavioral health field across the Bay Area and on the East Coast. Locally, she oversaw Family, Youth, and Children's Services in the City of Berkeley (and Albany) and was later promoted to the role of Manager of the Mental Health Services Division of the Health Services Department in the City of Berkeley between 2006-2012. Dr. Tribble has worked as a clinician and administrator in a variety of family mental health, medical, primary care, general mental health and forensic mental health settings.

Dr. Tribble holds a Bachelor's of Science Degree in Psychology from Howard University in Washington D.C., a Master's degree in Social Service/Social Work from Bryn Mawr College, a Master's degree in Clinical Psychology from the Philadelphia College of Osteopathic Medicine, and a Doctor of Psychology degree in Clinical Psychology from Philadelphia College of Osteopathic Medicine. She is also a Licensed Clinical Social Worker.

As you may know, I delayed the appointment of a permanent Director of Behavioral Health to allow myself time to better understand the needs of the department. During that time, I worked closely with ACBH leadership, participated in listening sessions with ACBH staff and had the Human Resources Department conduct a survey to learn what ACBH staff most wanted in the next ACBH Director. These experiences taught me a lot about the department and the work performed by ACBH staff. My admiration for the passion and dedication of ACBH employees has continued to grow and I am confident that we have found the right person at the right time to lead the department. I am thrilled that such an effective and passionate advocate and steward of behavioral health services will be leading ACBH into the future!

We could not have taken such a deliberate and in-depth approach to filling this position without having effective transitional leadership in place. I have the utmost respect and admiration for the job that Carol Burton has done as the Interim Director of Behavioral Health over the past two years. Carol has my sincere appreciation and respect for providing effective, stable, and insightful leadership throughout her time in the role.

Dr. Tribble will begin her new assignment on September 23, 2019. Please join me in congratulating her and welcoming her back to the Health Care Services Agency!
