#### Vision For Integrated Care Services

Improve Access To Primary Care Services for Specialty
 Behavioral Health Consumers

 Improve Access to Behavioral Health Services for Primary Care Safety Net Consumers through effective Care Coordination Comprehensive Integrated Care Services in Alameda County

- Tri-Directional Services that integrate Mental Health, SUD, and Primary Care Services
- Focus on enhancing competence of the County's "Safety Net" healthcare system and its workforce of providers
- Address the needs of County's "Safety Net" residents with mild, moderate, and severe BH conditions

Promoting Access to Health (PATH) Primary Care Clinics

 Integration of primary care clinic services in 3 County operated MH Centers

> Oakland Adult Community Support Center, Oakland, CA PCP: LifeLong Medical Care, Inc.

Tri-Cities Adult Community Support Center, Fremont, CA PCP: Bay Area Community Health Center

Eden Adult Community Support Center, San Leandro, CA PCP: LifeLong Medical Care, Inc.

#### Promoting Access to Health (PATH) Primary Care Clinics

- 888 Number of clients served in all 3 PATH Clinics in fiscal Year 2020-2021
- 68% of these clients are in good health

• 43% improved and stayed healthy through the year

#### Collaborative Care Services with County Safety Net Providers

#### Workforce Development Programs

- Contracting with 8 FQHCs to hire 11 Adult and 12 Pediatric Integrated BH Care Coordinators to work as part of their Primary Care and BH teams assisting complex BH clients.
  - 49,511 Number of care coordination services provided
  - 1017 Number of referrals from IBHCC to SMH through Access
  - 74 Number of link referrals to Substance Use Services

### ACBH Integrated Care Services with County Safety Net Providers

#### Workforce Development cont.

- Provide Primary Care Psychiatric Consultation Services to 8 FQHCs, SUD contract Providers, and one HIV Specialty Health Center
- Consultants assist Primary Care, BH Clinicians, and SUD Providers with BH assessments, diagnosis, and prescribing appropriate psychotropic medications.

ACBH Integrated Care Services with County Safety Net Providers

#### Workforce Development cont.

 Effective July 1, 2023, contracting with the Community Health Center Network (CHCN) to participate in "Care Transition Registered Nursing (CTRN) Project to help reduce overutilization of emergency rooms and hospital readmissions of Specialty BH patients by medical case management and care coordination services. Collaborative Care Services with County Safety Net Providers

 Co-Occurring SUD Recovery and Treatment Services for Specialty Mental Health consumers with substance use problems enrolled in 4 County operated Adult Mental Health Centers.

**Provider: Options Recovery Services** 

Collaborative Care Services with County Safety Net Providers

- Financial Support for Alameda Health System's Medication Assisted Treatment (MAT) Services at Highland General Hospital.
- Financial Support for Axis Community Health Center's Bridge Clinic to help improve timely access to crisis mental health and SUD services for residents living in Southern Alameda County.

#### **Goals for the Future**

- Continue to support Safety Net Healthcare projects that improve timely access for underserved County residents to Specialty behavioral health and primary care services.
- Identify and recommend funding new Workforce Development projects that improve care coordination and competency level of Safety Net primary care and BH providers.
